Beth Middleton Memorial Scholarship

The Beth Middleton Memorial Scholarship will be awarded to a current or former FCCLA state or national officer who exhibits outstanding leadership, scholarship and community service, and who demonstrates well-roundedness through various activities. Each applicant will be evaluated based on the application information provided, and a recipient will be selected by a selection committee. This scholarship is a \$400, two-part cash award per recipient payable directly to the college or university once (\$200) in the fall and once (\$200) in the spring of the recipient's first year. Funds must be applied toward tuition, room, and/or board. Application deadline is March 1, 2017 at 5:00 PM EST.

- has affiliated with national FCCLA by March 1, 2017
- has been a member for a minimum of 2 years (does not have to be consecutive)
- is a current or former FCCLA state or national officer
- is currently a senior (grade 12) in high school
- has a minimum 3.5 cumulative GPA (based on a non-weighted 4.0 scale)
- must maintain a 3.0 GPA in their post-secondary school in order to receive a second award payment.
- *Only one applicant per state is permitted.
