 - 6.1 Update from NLC—Kris Brockhoft

- -148 attendees at the 2017 NLC in Nashville, TN. 94 student members and 62 competed in STAR events with 37 Gold medals, 23 silver, and 2 bronze.
- -Vice President of Community Service Kayla Gullickson (Brookings) presided over the meeting and did a fabulous job representing SD.
- -We had 2 national officer candidates—Bridgette Nelson and Andrew Rasmussen. Both were elected as national officers (Bridgette—VP of Finance and Andrew—VP of Programs. Congratulations to both for a successful year!
- -SD had 10 members compete in Knowledge Bowl—Brookings and Clark—with the Brookings team for taking 2nd place in the nations!
- -Congratulations to Kayla Gullickson, 2016-17 National Officer; Andrew Rasmussen and Bridgette Nelson
- -National Award winners were Wessington Springs Junior High School, "Your Decision...Get a Career" 1st place and Brookings Sr. High School, "Highway to Health" runner-up
- -Webster had Fashion Design Scholarship and Kayla Gullickson received the Prestige Scholarship.
- -Brookings and Parkston Chapters presented 3 workshops. Kyle Sorbe served on the CEAT Team and worked to help carry out STAR Events at the meeting.
- -Tracy Kern, Cindy Brace and Kris served as Lead/Assistant LEAD STAR Event Consultants, and several members, advisers, and chaperones served as judges and room consultants.
- -Elliot Johnson and Josh Sorbe completed their responsibilities on the National Board of Directors
- --The Lead2Feed national outreach program is a general project called "Feed the Need in Your Community". Members apply leadership skills to a service project in their community and have the opportunity to receive more than \$300,000 in charity grants and technology packages

6.2 Update on National FCCLA--Bridgette Nelson, and Andrew Rasmussen

- -Will attend first national planning meeting next week and are starting to get information from national headquarters.
- -August 9 is the date for a national news conference on the review of the Team RSA
- -Capitol Leadership in Washington, D.C. in November
- -Clusters at Washington, D.C and Oklahoma City
- -National is looking for more chapters applying for program and project awards

6.3 State Adviser Update and Report—Kris Brockhoft

-There were 62 affiliated chapters during the 2016-2017 year and a membership increase -1827 paid FCCLA members for the school year (increase of 23 members); our goal is 2000 members

- -Discussion was held on having all registration go through DLG registration; the registration will increase from \$1.50 to approximately \$1.60 per individual.
- -Recommendations were made to have all registration go through the DLG registration but Kris and Macey will reach out to the Region Chairs to see if a consistent form could be developed to register non-competitive events. The Board recommended that what is more efficient for Kris would be the preferred direction to take.
- -School
- -Capital Leadership is November 8-10 in Washington D.C. There are 2 \$150 stipends available.
- "Go for the Red" membership kits were sent out is the new membership
- -New chapters and returning chapters: Lyman County, Dakota Valley, Lennox will affiliate; Andes Central and Bowdle again have advisers; Fort Pierre, Pierre Middle School/Pierre Senior High School, Britton/Hecla and Custer have an interest; Potential chapter from Aberdeen in the future
